Our products support providers in the delivery of care including oncology, cardiology, neurology, nuclear medicine, orthopedics, women's health, and pediatrics.

- **Milestone:** U.S. Food and Drug Administration (FDA) clearance for state-of-the-art deep learning-based technology that enables magnetic resonance (MR) cardiac imaging within a single heartbeat and can help reduce scan time by up to 83%^{a)}.

- **Milestone:** Pioneered the first handheld ultrasound in 2010. In 2021, we made it wireless and pocket-sized with crystal clear image quality for whole-body scanning and added intuitive software - all in the palm of clinicians' hands.

Pharmaceutical Diagnostics (PDX): We are a leading supplier of diagnostic agents to the radiology and nuclear medicine industry. Our diagnostic agents help clinicians assess patients to enable more precise diagnoses and better therapy selection. We distribute products globally, providing on-time delivery of quality products that help meet patient and procedural needs across modalities. PDX's diagnostic agents are complementary to the imaging and ultrasound devices we offer, including computed tomography (CT), angiography and X-ray, MR, single-photon emission computed tomography (SPECT) and positron emission tomography (PET), and are also compatible with systems from other equipment vendors.

- **Milestone:** Introduced the first and only FDA-approved PET agent for color imaging of amyloid plaque now being used to aid in the diagnosis of Alzheimer's disease in patients with cognitive decline.
